**Other miscellaneous explanatory notes:**

The feline euthanized was diagnosed with confirmed FIP. In 2022 we did intake on 3 adult cats that were in active end stage liver and kidney who passed shortly after their diagnosis. We also did intake on 10 kittens who had congenital deformities which did not survive longer than 5 months of age. The rest of the died in care mainly comprised of very sick neonates we took in as strays that were found by good samaritians. A part our focus shifted in the last 6 months of 2022 from in state to 2 of our out of state partners because our Executive Director came down with Covid and serious side effects from Long Covid, and the volunteers mainly pulled from these 2 out of state partners which could provide not only fully vetted felines but interstate health certificates as well. Due to the overwhelming need within local community, we took in a larger percentage of Strays and Owner Surrenders than normal to prevent them from ending up in already overcrowded VA Shelters however this also prevented us from pulling from some our smaller shelter partners as the average stay in foster care for strays and owner surrenders is much longer than shelter pulls, and this tied up our foster homes preventing us from pulling.
